These after school classes me the Expanded Learning requirements and are for all PVUSD students who will be in grades TK-6 in the 2023-2024 school year. This a tremendous opportunity that gives your child access to a free program to enrich their academic experience through language an mathematics, art, science, and athletics/physical fitness & play. Classes are offered every day until 6:00pm. Funding requirements allo us the opportunity to provide programs that include academic intervention, homework support, as well as amazing enrichment activities. Please know that homework assistance is available, however, enrollment in this program does not guarantee homework completion on a daily basis. Transportation is available. Students who usually walk home may do so or be picked up by natent/quardian. Start and end times to be determined. More information on specific program times will be shared prior to the first de of school, which is August 15. **Priority application deadline closed May 19, 2023.**

Current applications being accepted will be enrolled as capacity per site allows. Expanded Learning Opportunity Programs wi remain free for all TK-6th grade students (within site capacity levels). Programs are open to all TK-6th grade students, including pupil with disabilities. Priority enrollment will be given to foster youth, students in transition, and/or students that qualify for free an reduced school meals to ensure all students have access to essential resources. Expanded Learning will create and implement waitlist system if limited staff capacity prevents all students from successful enrollment in the program.

EARLY RELEASE POLICY

After School Programs are to be open 5 days a week Monday – Friday, and staffed until 6:00 pm. However, it is recognized that the requirement does not provide for the safety and interest of all students and families. Our district has elected to establish a reasonable at equitable Early Release Policy that applies to all grant-funded after school programs. Recognizing the fact that the district boundaries expansioned and that student safety is the primary responsibility of all persons associated with the program, the district huniformly elected to establish the following early release policy:

A child may be released early from the after school program prior to the end of program time at 6:00 p.m. based on the followin conditions:

- 1. Attending a parallel program (programs in the school or community centers such as soccer, basketball, etc.) as long as an agreeme or partnership with the program exists thus making this parallel program the child's enrichment component
- 2. Family Emergencies (such as death in the family, catastrophic incidents, etc.)
- 3. Medical appointments
- 4. Weather conditions (especially if the child walks home)
- 5. Child accidents or discipline that occur during program time (program staff should call parent or guardian)
- 6. Safe Transportation

POLIZA DE SALIDA TEMPRANA

El programa después de la escuela debe estar abierto 5 días a la semana de lunes a viernes y debe tener personal hasta las 6:00 pm. Se reconoce que este requisito no provee para la seguridad ni el interés de todos los alumnos y sus familias. Nuestro distrito ha elegido estableces una Póliza de Salida Temprana que aplica a todos los programas después de escuela que son fundados por otorgamientos. Reconociendo que los límites del distrito se extienden unas 125 millas cuadradas y que la seguridad de los alumnos es la responsabilidad de todas las personas asociadas con el programa, el distrito ha elegido establecer la siguiente Póliza de Salida Temprana:

Un alumno puede salir temprano del programa después de clases antes de que se termine a las 6:00 por las siguientes razones:

- 1. Están asistiendo a un programa paralelo (programas en la escuela o centros comunitarios como fútbol, básquetbol, etc.) siempre y cuando exista un acuerdo u asociación con el programa haciendo este el componente de enriquecimiento
- 2. Emergencias Familiares (como muerte en la familia, incidentes catastróficos, etc.)
- Citas médicas
- 4. Condiciones del tiempo (especialmente si el alumno camina a casa)
- 5. Accidentes o disciplina que ocurren durante las horas del programa (personal del programa deben llamar a padre/ guardián)
- 6. Transporte seguro

PVUSD Teach Program EXPANDED LEARNING OPPORTUNITIES PROGRAM

Students participating in After School Academic Enrichment Programs may have the opportunity throughout the year participate in one or multiple of the Teach Programs including Fitness 4 Life (F4L), Art Teach, Guitar Teach, Science Workshot Tech Teach & Wetlands Watch. These programs have various parts & components including bicycling, running, swimmin dance, and other physical activities, art, guitar, hands-on science (using tools & hot glue-guns), tech computer classes, out-do education and field trips. These programs are offered in collaboration with community partners. Current community partner included The City of Watsonville, Cultural Council of Santa Cruz, Watsonville Wetlands Watch and Fitness 4 Life.

F4L Permission Information

F4L offers students various forms of health, well-being and physical activity classes including bicycling, running, swimming nutrition, dance, and other physical activities. I grant permission to my child to take part in the Nutrition Exposé, which wi involve hands-on practical nutrition education; foods and beverages preparation and consumption. I understand that this wi involve training in the safe use of kitchen knives and other kitchen implements, and safe use of kitchen fire. While I understant that the facilitators of the F4L Nutrition Exposé program will observe safety regulations and practices while engaging the kids it this exercise, I know that exposure to kitchen implements and fire never-the-less bears risks. I attest that the bicycle an equipment my child will use for the F4L program will be in good mechanical condition, and that F4L is not legally responsible for injuries that may result from bicycles provided by the organization or repairs made to my child's bicycle by F4L staff or third party individual or entity volunteering or hired. I understand that wearing a helmet can prevent serious injury and my child will wear one in training and during bicycling events. I agree to defend, indemnify and hold harmless the Pajaro Valley Unified School District, its Board of Trustees, officers, agents and employees, individually and collectively, from and against all costs losses, claims, demands, suits, actions, payments and judgments, including legal and attorney fees, arising from personal or bodily injuries, property damage or otherwise, regardless of and however caused, brought or recovered against any of the above individuals that may arise for any reason from or during or be alleged to be caused by the undersigned's participation in the F4I Program.

I understand that with this waiver, release, and assumption of risk is to be binding on my heirs, executors, administrators, and assigns. I hereby grant full permission to PVUSD, Extended Learning Programs, The Teach Programs and community partnerships and other such entities authorized by Extended Learning to use any photographs, video images, motion pictures, or any other record of this event for any legitimate purpose. Employees of PVUSD will not be held responsible for claims against the District for any damages, awards, claims, or liabilities that may arise from any unauthorized uses or copyright violations of students' work and/or photographs.

Pajaro Valley Unified School District Publishing Requirements for Student work:

- Child's telephone number or home address will not be included.
- Information that indicates the location of a pupil at an exact hour, other than their attendance in a school or participation in a school activity, will not be included.
- Documents containing objectionable material are not allowed, nor may web pages point directly or indirectly at such material.
- Documents must conform to the policies and procedures of the PVUSD Acceptable Use Policy.
- Documents must be reviewed and approved by a sponsoring teacher before its publication.
- Only the first name of elementary students' will be posted.
- Students will continue to own the copyright of any work published.
- Students are taught Digital Citizenship, which include lessons safeguarding their own data and their responsibilities in regard to the personal information of others when online.
